Attached for your information is the DRAFT Admissions and Continued Occupancy Policy ("ACOP") and Lease for the Westhaven Park Apartments Phase IIB mixed-income community (Phase IIB of the Henry Horner Homes redevelopment) and subsequent Horner rental phases. The Chicago Housing Authority (CHA), the developer, and its property manager are working, in consultation with the Horner Residents Committee, to develop a draft ACOP and Lease for use at the private development to be known as Westhaven Park Apartments Phase IIB and subsequent private rental developments at the Henry Horner Homes redevelopment. The public housing units within this development will be available as replacement public housing units.

The public comment period for the Draft ACOP and Lease for Westhaven Park Apartments Phase IIB and subsequent Horner rental developments will run from August 14, 2006 through September 12, 2006.
