1) Background

Chicago Housing Authority (CHA) has identified LCPtracker’s Labor Compliance software as the computer system of choice to meet its labor compliance program requirements. LCPtracker is an Application Service Provider (ASP) web-hosted software program from LCPtracker, Inc. that minimizes paperwork and labor hours when enforcing a Labor Compliance Program on public works construction projects. LCPtracker creates an online database of all certified payroll reports (CPR), generates audits logs and has standard letters, electronic documents, attachments and many other features for correspondence to contractors.

LCPtracker consists of three modules-databases: a contractor database, an administrator database, and a prevailing wage database. These three modules work together to provide a web-based program to capture, check and report on Certified Payroll Reports, as well as other related data and reporting. The eDocuments element is an additional function which enhances the posting and collection of documentation. Each component is briefly described below:

- **Contractor Module:** The contractor database allows the contractor to enter the Certified Payroll data online. The system will check the contractor data against the prevailing wage database and alert the contractor of any problems. The contractor can then certify and submit their Certified Payroll Reports (CPR) online. Several reports exist to help the contractor manage the submittal of CPR reports. The contractor can also define their subcontractors in the system, which allows them to submit on-line as well.
- **Administrator Module:** The administrator database allows the administrator to track the status of CPR submittal, review submitted CPRs, and report on the data in the CPRs in a wide variety of ways. The administrators can also track the status of all documents required or created with respect to the prevailing wage reporting. A site visit reporting capability is also provided.
- **Prevailing Wage Database:** A prevailing wage database contains the wage information appropriate to the project. This database is indexed by location, rates, project, labor craft, and labor classification within that craft. You can maintain this database or you can contract with LCPtracker to maintain the database. The prevailing wage database has a robust tool that checks, validates and reports issues to the contractors and administrator automatically.
- **eDocuments:** Allows the administrator, to create standard document submittals that are electronically uploaded. Any type of file or document can be tracked in the labor compliance Database.

3) LCPtracker Standard Functionality

LCPtracker, out-of-the box software, provides a significant number of standard features that are available to CHA.

These include:

- **Web-based prevailing wage/labor compliance software**
- **Contractors report Certified Payroll Reports electronically using esignature technology.**
- **Validation Engine which includes over 50 mathematical and logical checks which are done to each, incoming payroll. System has checks for meeting prevailing wage, overtime paid, apprentice approval, etc. Administrators have ability to set these and to define how they want contractors notified of any potential errors/discrepancies.**
- **System contains a prevailing wage database in which appropriate wage decisions are applied to each project. System checks incoming payrolls against this database for potential errors.**
- **LCPtracker generates over 50 standard reports including Certified Payroll Reports, Summary CPR, Late Report, Penalty/Restitution Calculation, Workforce Summary Reports, ARRA/Stimulus Reports, Apprentice Reports, including Apprentice to Journeymen Ratios, Management List Reports, HUD Reports, Holiday Report, and many more.**
- **Robust, secure and scalable architecture capable of handling millions of records.**
- **Electronic documents module which allows the administrator to collect, monitor and catalog any electronic documents, i.e., fringe benefit statements, apprentice certifications, etc.**
- **Site Visit Interview form and report. Site visit may be done at job site using a wireless PDA device. The site visit report then cross-references to CPR submitted for the week and discrepancies are highlighted.**
- **Letters/Templates – standard letters may be used to send out to contractors via email, or printing and mailing. Basic company and address data is populated to the template.**
- **LCPtracker interfaces with many, industry leading contractor accounting systems such as QuickBooks, Construction Partner, ADP, etc. Additionally, LCPtracker offers Direct Payroll Interface and can interface most contractor payroll files to our database.**
- **Administrators have the ability to accept/reject payrolls and send and track Notices and Responses to and from the contractors.**
- **Federal databases collect SSNs and addresses of employees, but do not display them on the CPRs.**
- **Ad-hoc reporting module is available as an add-on service.**
- **LCPtracker's training program for administrators and contractors alike includes, onsite/web-hosted sessions, online weekly classes, user manuals, and numerous eTraining videos and support documents.**
- **Multi-tiered security and access rights for staff.**
- **24/7 availability of system with 99% up time**

4) Assumptions:

The following assumptions govern the delivery of this Scope of Work:

- CHA is responsible for the provision of contract data in LCPtracker's standard import format.
- The basic functionality of LCPtracker will be implemented during this project with no customizations, except as identified in this statement of work.
- CHA will be responsible for defining any additional structure during the application use.
- CHA will provide the necessary DBA and Programmer Analyst resources required to support the project.
- LCPtracker will be responsible for backup and recovery of project instances, user setups, installation of program and data objects, configuration management and control and performance tuning.
- CHA will designate a full time Project Manager to lead the project, from CHA's perspective, chair project meetings, expedite project decisions, provide access to key personnel as required and provide communications to CHA project team concerning progress and issues.
- LCPtracker will provide a project manager to give guidance to CHA during the use of the system.
- LCPtracker is responsible for ongoing, pre-scheduled, web-based, administrator and contractor training.
- LCPtracker is responsible for the support and production operations of the system.

5) LCPtracker Administrative & Contractor Training

LCPtracker contains a variety of training tools available to CHA Administrators and contractors to allow them to increase their proficiency in utilizing the system. There is no additional cost associated with using these training methods; they are included in the annual license. These tools include:

1. Instructor-led training
2. Self-led video training
3. Self-led training document review
4. Contractor instruction manual

Instructor-led training consists of web-based training classes whereby the instructor will walk the contractor through the LCPtracker database. Content covered includes: setting up employees, setting up subcontractors, creating an esignature password, selecting crafts/classifications for employees, setting default hourly rates for fringes, entering a payroll record (both manual and upload), definition of notices and how to clear them, certifying both performing and

non-performing payrolls, managing apprentices, editing and re-certifying a CPR, use of eDocuments, and use of reports. Web classes are routinely offered twice per week, and onsite sessions may be scheduled as well.

Self-led video training consists of a series of eTraining videos that a contractor may view at his leisure. Once a contractor receives a user id and password from LCPtracker, he may login to view one of several training videos posted on our eTraining link. Many of these are short in duration and cover specific topics such as, editing an existing CPR, setting up an eSignature password, etc. There is also a full-length training session, which details all of the content in the instructor-led training.

Self-led training document review consists of a series of eTraining documents that a contractor may view at his leisure. Once a contractor receives a user id and password from LCPtracker, he may login to view one of several training documents posted on our eTraining link. Most of these documents have screen shots from the database, as well as, text to follow along.

Contractor instruction manual is a comprehensive guide to using LCPtracker. It is made available to contractors at the onsite training session and is also available on the eTraining link in LCPtracker.

6) Customer Support

LCPtracker provides support services to clients to address needs by utilizing experienced Project Managers and support staff empowered to assist clients and contractor users. All of the items listed below are standard support features for our clients.

1) GO-TO ASSIST REMOTE LOGIN BY OUR SUPPORT TEAM

11) Terms

The value of construction is calculated by adding up all active projects in the system. The value of projects marked as “Active” within the database is determined by the total of project Budget amounts. The “Budget” field is defined as the construction Bid Amount of the award. Change orders or increases are not factored in. Construction value is determined only by the original bid amount of the award.

1. **This calculation is done monthly by LCPtracker. If a project is completed and closed, the project will no longer be counted in that month's open active projects. The annual fee does not change unless the following occurs.**
 - a. **If the construction projects entered in LCPtracker exceed the level purchased in any month during the contract year, the next construction level difference will be invoiced. This invoice becomes due and payable for the existing year's annual contract amount.**
 - b. **Subsequent year renewals will be calculated and invoiced at the anniversary renewal month's open active project construction value for that month.**
2. **All fees for the annual contract are due at signing of contract.**
3. **Customized or additional services are charged 50% up front upon signing of the contract, and 50% upon the delivery of the customization or service to the client.**
4. **Data entry for prevailing wage data is charged at \$75 per hour at the end of the month that the data entry service was provided.**
5. **Annual contracts may be cancelled on the annual anniversary only with written request to cancel.**
6. **Semi-annual or annual invoice terms are acceptable.**
7. **Development, customization and other software related services are \$150.00 per hour.**
8. **Client is responsible to close projects as they are completed. Projects that have active status will be billed.**
9. **LCPtracker reserves the right to validate actual construction costs of projects managed by LCPtracker. Client agrees to provide this data to LCPtracker upon our request.**
