AUTHORIZATION TO EXERCISE ONE-YEAR OPTION FOR CONTRACT NUMBER 11037 WITH AON RISK SERVICES, INC. FOR BROKERAGE AND CONSULTING SERVICES

It is recommended that the Board of Commissioners authorize the Chief Executive Officer or his designee to execute an amendment extending Contract No. 11037 with Aon Risk Services, Inc. for Insurance Brokerage and Consulting Services for the period of February 1, 2013 to January 31, 2014 in an amount not-to-exceed \$214,200.00.
